## VOLVO CARS CLEAR LAKE GRAND OPENING SWEEPSTAKES

## TERMS AND CONDITIONS

## **NO PURCHASE NECESSARY**

- 1. **INTRODUCTION:** These Terms and Conditions govern your participation in the Volvo Cars Clear Lake Grand Opening Sweepstakes (the "Sweepstakes") presented by Bob Howard Imports, LLC d/b/a Volvo Cars Clear Lake (hereinafter referred to as "Volvo Cars Clear Lake"). By submitting an entry registration form to Volvo Cars Clear Lake, you signify your acceptance of these Terms and Conditions and you agree to abide by these Terms and Conditions. If you do not agree to these terms, please do not submit an entry registration form to Volvo Cars Clear Lake.
- 2. **ELIGIBILITY:** The Sweepstakes is open only to individuals who: (i) are legal residents of the United States and the State of Texas; (ii) are 18 years of age or older at the time of entry; (iii) have a valid mailing address within Harris County, Texas, Galveston County, Texas, Fort Bend County, Texas, Brazoria County, Texas, Chambers County, Texas, Matagorda County, Texas, Jefferson County, Texas, or Liberty County, Texas; (iv) own a registered Volvo vehicle that is a year model of 2016 or newer (an "Eligible Vehicle") and was purchased by such individual on or prior to December 31, 2024; (v) bring in an Eligible Vehicle to Volvo Cars Clear Lake, located at 17970 Gulf Fwy, Friendswood, TX 77546, for a free multi-point inspection; (vi) execute and submit to Volvo Cars Clear Lake a registration form that includes the individuals basic contact information (name, street address, phone number, and email address); and (vii) agree to execute any and all releases and waivers as required by Volvo Cars Clear Lake. Employees, agents, officers and directors of Volvo Cars Clear Lake, its affiliates, subsidiaries, distributors, advertising and promotion agencies and their immediate family members and/or those living in the same household of each, and anyone involved in the production, development or handling of the Sweepstakes (collectively, the "Released Parties") are not eligible to enter or win in this promotion.

Eligible participants are automatically entered into the Sweepstakes upon meeting the eligibility requirements above. If an individual does not desire to bring in an Eligible Vehicle for a free multi-point inspection (as described above in Section 2), then such individual may enter into and participate in the Sweepstakes by mailing an entry submission to Volvo Cars Clear Lake that includes a reference to the "Volvo Cars Clear Lake Grand Opening Sweepstakes" and will include the following basic contact information: name; street address; phone number; email address; and year, make, model and VIN of the Volvo car the individual owns; provided, however, an individual entering into the Sweepstakes by mailing an entry submission must meet the eligibility requirements (i)-(iv) outlined in Section 2 above. Eligible participants, including their immediate family members and/or those living in the same household, are limited to only one (1) entry into the Sweepstakes per Eligible Vehicle. 5. **RANDOM DRAWING:** The name of the winner will be selected in a random drawing from among all eligible entries received ("Potential Winner") on or about December 15, 2025 or the first business day of Volvo Cars Clear

Lake's grand opening. The Potential Winner will be notified via email and/or phone within approximately 72 hours of the completion of the drawing. The Potential Winner may be required to execute and return a waiver and release form provided by Volvo Cars Clear Lake within forty-eight (48) hours of the date of notification or the prize may be forfeited and an alternate Potential Winner selected. Volvo Cars Clear Lake is not and will not be held responsible for delays in the selection of a Potential Winner, notification of Potential Winner, or delivery of the Grand Prize. It is the responsibility of the participant to ensure that their contact information is accurate and up-to-date.
